As per the requirements under the Regulations 19(4) read with Sub-clause (3) Para A of Part D of Schedule II of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended from time to time (the "Listing Regulations") and such other regulatory provisions, as applicable the Nomination and Remuneration Committee of the Company (the "NRC") is required to devise a policy for having diversity on the board of directors (the "Board") of RCRS Innovations Limited (Formerly Known as RCRS Innovations Private Limited) ("the Company").
